# A BILL FOR AN ACT

MAKING APPROPRIATIONS FOR COLLECTIVE BARGAINING COST ITEMS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 SECTION 1. Act 55, Session Laws of Hawaii 2015, is amended  
2 as follows:

3 1. By amending section 17 to read:

4 "SECTION 17. There are appropriated or authorized from the  
5 sources of funding indicated below to collective bargaining  
6 statewide (BUF 102) the following sums, or so much thereof as  
7 may be necessary, to fund for fiscal biennium 2015-2017, all  
8 collective bargaining cost items for salary increases and other  
9 wage related costs in the agreement negotiated with the  
10 exclusive bargaining representative of collective bargaining  
11 unit (14):
