A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The purpose of this Act is to repeal the
2 statutory provision that provides teachers and educational
3 officers with annual increments or other longevity step
4 increases. Salary increases and step increases are negotiated
5 with both teachers and educational officers pursuant to section
6 89-9, Hawaii Revised Statutes, and, therefore, provisions
7 relating to annual increments and step increases are no longer
8 necessary.

9 SECTION 2. Section 302A-623, Hawaii Revised Statutes, is
10 amended to read as follows:

11 "~~§~~**302A-623**~~§~~ **Salary ranges, educational officers.**

12 Salary ranges for educational officer positions of the
13 department shall be determined by the board based on the
14 position classification/compensation plan approved by the board.
15 Salary ranges for educational officer positions shall be subject
16 to the requirements of ~~sections~~ section 302A-625 ~~[and 302A-~~
17 ~~626]."~~

1 SECTION 3. Section 302A-703, Hawaii Revised Statutes, is
2 amended by amending subsection (b) to read as follows:

3 "(b) The department shall develop a definition of
4 "exemplary" in consultation with the appropriate collective
5 bargaining representative.

6 Salary ranges and salary incentives for educational officer
7 positions shall be subject to the requirements of [sections]
8 section 302A-625 [and 302A-626]."

9 SECTION 4. Section 302A-626, Hawaii Revised Statutes, is
10 repealed.

11 [~~"§302A-626 Salary increases; annual, longevity. (a)~~
12 ~~Teachers and educational officers who have completed a year's~~
13 ~~satisfactory service and who have complied with the other~~

Description:

Repeals annual increment and step salary increases for Department of Education teachers and educational officers.

JUSTIFICATION SHEET

DEPARTMENT: Education.

TITLE: A BILL FOR AN ACT RELATING TO EDUCATION.

PURPOSE: Repeals statutory provision for annual increment and step salary increases for Department of Education teachers and educational officers.

MEANS: Repeal of section 302A-626, Hawaii Revised Statutes (HRS).

JUSTIFICATION: Wages, which include incremental and longevity steps and movements between steps within the salary range, are mandatory subjects of bargaining pursuant to the collective bargaining law contained in section 89-9, HRS, which makes section 302A-626, HRS, obsolete, meaningless, and confusing. It was initially enacted in 1953 (as section 297-34, HRS) prior to the establishment of collective bargaining laws for public employees in 1970.
