
A BILL FOR AN ACT

RELATING TO LICENSING OF PRIVATE TRADE, VOCATIONAL, AND
TECHNICAL SCHOOL.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that private trade,
2 vocational, and technical schools provide specialized training
3 for a number of professions in the State, including those in
4 massage therapy, healthcare, tax preparation, and maritime
5 activities. Section 302A-425, Hawaii Revised Statutes,
6 prohibits these schools and other private organizations or
7 corporations from operating prior to being licensed by the
8 department of education. The department of education has had
9 this responsibility since 1939, when the focus of the regulation
10 was to ensure the quality of education and instruction at those
11 schools providing post-secondary training below the college
12 level.

13 The legislature further finds that Act 57, Session Laws of
14 Hawaii 1998, amended section 302A-425, Hawaii Revised Statutes,
15 to declare that the purpose of the regulation is to protect
16 consumers from false, deceptive, misleading, and unfair
17 practices and to ensure adequate educational quality. Auditor's



1 Report No. 02-08, *A Study on the Licensing of Private Trade,*
2 *Vocational, and Technical Schools,* acknowledged that the
3 declaration of purpose added to section 302A-425, Hawaii Revised
4 Statutes, by Act 57, Session Laws of Hawaii 1998, brought into
5 question the appropriateness of the program's administrative
6 placement within the department of education.

7 The legislature additionally finds that, during the regular
8 session of 2015, the legislature passed S.C.R. No. 46, S.D. 2,
9 requesting the department of commerce and consumer affairs and
10 department of education to convene a working group to evaluate
11 and review the current licensing program for private trade,
12 vocational, and technical schools. The working group
13 collaborated to gather information and develop findings and
14 recommendations. The working group jointly recommended that the
15 licensure program be narrowed in scope, but were unable to come
16 to any other joint recommendations.

17 The legislature finds, however, that the department of
18 education is no longer an appropriate location for such a
19 licensing program. The department of education's primary
20 mission is educating students in grades kindergarten through
21 twelve, and lacks experience providing post-secondary education



1 and regulating post-secondary institutions. The legislature
2 further finds that the department of education does not have the
3 capacity or expertise in the specialized curricula of the
4 various private trade, vocational, and technical schools
5 currently under its licensing jurisdiction to effectively
6 administer the requirements of section 302A-425, Hawaii Revised
7 Statutes.

8 The legislature additionally finds that the department of
9 commerce and consumer affairs has established licensing and
10 regulation processes, consistent with its mission of consumer
11 protection, and several trade and vocational schools now receive
12 state licensure for business operations through the department
13 of commerce and consumer affairs. Consequently, the legislature
14 also finds that the regulation and licensing of private trade,
15 vocational, and technical schools at the post-secondary level
16 belongs more appropriately within the department of commerce and
17 consumer affairs.

18 The purpose of this Act is to transfer the licensing and
19 regulation program for private trade, vocational, and technical
20 schools from the department of education to the department of
21 commerce and consumer affairs.



1 SECTION 2. The Hawaii Revised Statutes is amended by
2 adding a new chapter to be appropriately designated and to read
3 as follows:

4 "CHAPTER

5 PRIVATE TRADE, VOCATIONAL, AND TECHNICAL SCHOOLS

6 § -1 Purpose. The purpose of the licensing and
7 regulation program for private trade, vocational, and technical
8 schools is to protect consumers against practices by such
9 schools that are false, deceptive, misleading, or unfair, and to
10 help ensure adequate educational quality.

11 § -2 License required for private trade, vocational, or
12 technical school. (a) No private trade, vocational, or
13 technical school shall be operated by any person or persons,
14 firm, or any other private organization or corporation for the
15 purpose of teaching any trade, occupation, or vocation unless
16 there is first secured from the department of commerce and
17 consumer affairs a license issued in accordance with this
18 chapter and in a form as the department of commerce and consumer
19 affairs may direct.

20 (b) This chapter shall only apply to those private trade,
21 vocational, and technical schools that require licensure for the



1 purpose of offering federal student aid, educational grants, or
2 other funding sources requiring state-level licensure, or for
3 fulfilling professional licensure requirements for students.
4 The determination shall be made by the department of commerce
5 and consumer affairs.

6 **§ -3 License; fees.** (a) The department of commerce and
7 consumer affairs shall issue a license to a private trade,
8 vocational, or technical school subject to this chapter that
9 pays the appropriate fees and complies with all requirements of
10 this chapter and any rules adopted by the department of commerce
11 and consumer affairs.

12 (b) The department of commerce and consumer affairs shall
13 determine an appropriate fee structure, to include separate fees
14 for an initial application and renewal application, for the
15 licensing of private trade, vocational, and technical schools
16 subject to this chapter.

17 **§ -4 Suspension and revocation of license; procedure.**

18 (a) The department of commerce and consumer affairs, after
19 notice and opportunity for a hearing, may suspend or revoke a
20 license at any time when, in the judgment of the department of
21 commerce and consumer affairs, the licensee is not complying



1 with this chapter or the rules adopted thereunder by the
2 department of commerce and consumer affairs. The notice of
3 hearing shall be served personally or sent to the licensee by
4 registered or certified mail with return receipt at the
5 licensee's last known address.

6 (b) Notice of suspension or revocation shall be served
7 personally upon the licensee or sent to the licensee by
8 registered or certified mail with return receipt, and the
9 licensee shall forward the licensee's license at once to the
10 department of commerce and consumer affairs and immediately
11 cease to operate the private trade, vocational, or technical
12 school.

13 (c) All proceedings shall be subject to chapter 91.

14 § -5 **Penalty.** Any person, firm, or corporation that
15 violates the requirements of this chapter shall be fined not
16 more than \$100, or imprisoned not more than ninety days, or
17 both, for each violation.

18 § -6 **Rules.** The department of commerce and consumer
19 affairs shall adopt rules, pursuant to chapter 91, to carry out
20 this chapter's purpose and enforcement."



1 SECTION 3. Section 302A-101, Hawaii Revised Statutes, is
2 amended as follows:

3 1. By amending the definition of "license" to read:

4 "License" means the recognition granted by the Hawaii
5 teacher standards board to an individual to practice the
6 profession of teaching. [~~This definition shall not apply to the~~
7 ~~term "license" as it is used in sections 302A-425 to 302A-427.~~]"

8 2. By deleting the definition of "private trade,
9 vocational, or technical school".

10 [~~"Private trade, vocational, or technical school" means~~
11 ~~any plan or method used by any person or persons, firm, or any~~
12 ~~other organization or corporation for giving instruction in any~~
13 ~~form or manner in any trade, occupation, or vocation for a~~
14 ~~consideration, reward, or promise of whatever nature, including~~
15 ~~correspondence schools located within the State, except as~~
16 ~~follows:~~

17 ~~(1) Schools maintained, or classes conducted, by employers~~
18 ~~for their own employees where no fee or tuition is~~
19 ~~charged;~~



- 1 ~~(2) Courses of instruction given by any fraternal society,~~
2 ~~benevolent order, or professional organization to its~~
3 ~~members, which courses are not operated for profit;~~
- 4 ~~(3) Flying schools qualified under the Federal Aviation~~
5 ~~Administration;~~
- 6 ~~(4) Classes conducted for less than five students at one~~
7 ~~and the same time;~~
- 8 ~~(5) Classes or courses of instruction that are conducted~~
9 ~~for twenty or fewer class sessions during any twelve~~
10 ~~month period;~~
- 11 ~~(6) Avocational, hobby, recreation, or health classes or~~
12 ~~courses;~~
- 13 ~~(7) Courses of instruction on religious subjects given~~
14 ~~under the auspices of a religious organization; and~~
- 15 ~~(8) Schools registered by the department of commerce and~~
16 ~~consumer affairs or by boards and commissions placed~~
17 ~~in the department of commerce and consumer affairs for~~
18 ~~administrative purposes-"]~~

19 SECTION 4. Section 302A-424, Hawaii Revised Statutes, is
20 repealed.

2 ~~The department, at its discretion, may regulate schools,~~
3 ~~classes, or courses excepted from the definition of "private~~
4 ~~trade, vocational, or technical school"."]~~

5 SECTION 5. Section 302A-425, Hawaii Revised Statutes, is
6 repealed.

7 ~~["§302A-425 License required for private trade,~~
8 ~~vocational, or technical school. No private trade, vocational,~~
9 ~~or technical school shall be operated by any person or persons,~~
10 ~~firm, or any other private organization or corporation for the~~
11 ~~purpose of teaching any trade, occupation, or vocation unless~~

20 SECTION 6. Section 302A-426, Hawaii Revised Statutes, is
21 repealed.

16 SECTION 7. Section 302A-427, Hawaii Revised Statutes, is
17 repealed.

18 ~~["§302A-427] Powers of department. No license shall be~~
19 ~~issued under sections 302A-424 to 302A-428 until the department~~
20 ~~has approved the method and content of the advertising, the~~
21 ~~standards and the methods of instruction, and the equipment~~



1 ~~provided. The department may consult with trade or vocational~~
2 ~~experts as to the equipment provided and the standards and~~
3 ~~methods of instruction offered. The department may adopt~~
4 ~~reasonable rules relating to the enforcement of sections 302A-~~
5 ~~424 to 302A-428."]~~

6 SECTION 8. Section 302A-428, Hawaii Revised Statutes, is
7 repealed.

8 [~~["§302A-428] Penalty. Any person, firm, or corporation~~
9 ~~that violates sections 302A-424 to 302A-428 shall be guilty of a~~
10 ~~misdemeanor, but shall be subject to a maximum fine of not more~~
11 ~~than \$100 or imprisonment for not more than ninety days, or~~
12 ~~both."]~~

13 SECTION 9. All rights, powers, functions, and duties
14 previously performed by the department of education under
15 sections 302A-424 to 302A-428, Hawaii Revised Statutes, are
16 transferred to the professional vocational licensing division of
17 the department of commerce and consumer affairs; provided that
18 the department of education shall retain the department's
19 existing rights, powers, functions, and duties until July 1,
20 2018.



1 SECTION 10. All rules, policies, procedures, guidelines,
2 and other material adopted or developed by the department of
3 education to implement the provisions of sections 302A-424 to
4 302A-428, Hawaii Revised Statutes, shall be repealed upon
5 transfer to the department of commerce and consumer affairs.

6 SECTION 11. All deeds, leases, contracts, loans,
7 agreements, permits, or other documents executed or entered into
8 by or on behalf of the department of education pursuant to
9 sections 302A-424 to 302A-428, Hawaii Revised Statutes, shall
10 remain in full force and effect. Upon the transfer on July 1,
11 2018, every reference to the department of education or the
12 superintendent of education in those deeds, leases, contracts,
13 loans, agreements, permits, or other documents shall be
14 construed as a reference to the department of commerce and
15 consumer affairs or the director of commerce and consumer
16 affairs, as appropriate.

17 SECTION 12. The department of education and the department
18 of commerce and consumer affairs shall collaborate to implement
19 the transfers and transitions on July 1, 2018, required under
20 this Act with as little disruption as possible to ongoing
21 duties, responsibilities, and public services provided.



1 SECTION 13. Statutory material to be repealed is bracketed
2 and stricken.

3 SECTION 14. This Act shall take effect upon its approval;
4 provided that sections 2 to 11 shall take effect on July 1,
5 2018.
