# A BILL FOR AN ACT

RELATING TO HEALTH.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1           SECTION 1. Chapter 321, Hawaii Revised Statutes, is  
2 amended by adding a new section to be appropriately designated  
3 and to read as follows:

4           "§321-     License, relicense, certification, and  
5 recertification fees. (a) The department shall charge and  
6 collect fees for the licensure, relicensure, certification, and  
7 recertification of the following facilities:

8           (1) Not more than \$           per year for adult residential  
9           care homes;

10          (2) Not more than \$           per year for expanded adult  
11          residential care homes;

12          (3) Not more than \$           per year for developmental  
13          disabilities domiciliary homes;

14          (4) Not more than \$           per year for community care  
15          foster family homes;

16          (5) Not more than \$           per year for adult day care  
17          centers;

1        (6) Not more than \$ \_\_\_\_\_ per year for adult foster  
2        homes for developmentally disabled individuals; and

3        (7) Not more than \$ \_\_\_\_\_ per year for case managers  
4        having purview of facilities specified in paragraphs  
5        (1) to (6).

6        (b) The fees shall be deposited into the general fund to  
7        support the licensing, relicensing, certification, and  
8        recertification of facilities specified in this section.

9        (c) The department shall adopt rules pursuant to chapter  
10       91 as necessary to carry out the purposes of this section."

11       SECTION 2. The department of health shall submit a report  
12       to the legislature no later than twenty days prior to the  
13       convening of the regular session of 2017 on the following:

14       (1) The nexus and use of the fees collected pursuant to  
15       this Act;

16       (2) A brief description of any operational problems or  
17       legal impediments that are anticipated to affect  
18       collection of the fees or have affected collection of  
19       the fees; and

20       (3) With respect to community care facilities, a cost  
21       analysis on the savings to the State in relation to

1 providing health care services to the elderly and  
2 disabled persons.

3 SECTION 3. New statutory material is underscored.

4 SECTION 4. This Act shall take effect upon its approval.
