## SENATE RESOLUTION

REQUESTING THE ACCESS HAWAII COMMITTEE, HAWAII INFORMATION CONSORTIUM, AND EACH STATE AGENCY WHO CURRENTLY HAS A PARTNERSHIP WITH THE HAWAII INFORMATION CONSORTIUM TO COLLABORATE AND PROVIDE THE LEGISLATURE WITH A COMPREHENSIVE PROGRESS REPORT REGARDING THE ACTIVITIES AND EXPENSES OF THE STATE'S INTERNET PORTAL.

1 WHEREAS, in 1999, legislation was enacted to establish the  
2 Internet portal project to redesign the State's website to serve  
3 as a single access point for the State's agencies to provide  
4 electronic access to services and information; and  
5

6 WHEREAS, the State entered into a contract with the Hawaii  
7 Information Consortium to establish, develop, maintain, and  
8 expand the State's Internet portal to increase electronic access  
9 and commerce among the State's residents, businesses, and  
10 government entities; and  
11

12 WHEREAS, in 2000, the Access Hawaii Committee was  
13 established to provide oversight of the Internet Portal manager  
14 and the State's Internet portal activities; and  
15

16 WHEREAS, since the establishment of the State's Internet  
17 portal, the State has moved many services online to provide  
18 electronic access; and  
19

20 WHEREAS, since the establishment of the State's Internet  
21 portal, the Legislature has actively supported the portal and  
22 would like to continue to do so; now, therefore,

24 BE IT RESOLVED by the Senate of the Twenty-eighth  
25 Legislature of the State of Hawaii, Regular Session of 2016,  
26 that the Access Hawaii Committee, Hawaii Information Consortium,  
27 and each state agency who currently has a partnership with the  
28 Hawaii Information Consortium are requested to collaborate and  
29 provide the Legislature with a comprehensive progress report  
30 regarding the activities and expenses of the State's Internet  
31 portal; and

1 BE IT FURTHER RESOLVED that the progress report contain  
2 information pertaining to the State's Internet portal for each  
3 year since the establishment of the Internet portal project, as  
4 follows:

- 6 (1) Total visits per day, average time expended, bounce  
7 rates, new visitor count, and sources of site traffic  
8 for each web-based application;
- 9
- 10 (2) Gross amount collected through the portal;
- 11
- 12 (3) Service fees paid by consumers to use each web-based  
13 application;
- 14
- 15 (4) Monies paid by consumers to each state agency who  
16 currently has a partnership with the Hawaii  
17 Information Consortium for licensing, permits, taxes,  
18 records, registrations, and certificates for each web-  
19 based application;
- 20
- 21 (5) Any other monies collected by the Hawaii Information  
22 Consortium relating to the operation of the portal;  
23 and

- 25 (6) Monies paid, itemized by each web-based application,  
26 by the State to the Hawaii Information Consortium for  
27 building, implementing, operating, maintaining, and  
28 hosting the portal; and

30 BE IT FURTHER RESOLVED that the Access Hawaii Committee,  
31 Hawaii Information Consortium, and each state agency who  
32 currently has a partnership with the Hawaii Information  
33 Consortium are requested to submit the progress report,  
34 including any proposed legislation, to the Legislature no later  
35 than twenty days prior to the convening of the Regular Session  
36 of 2017; and

38 BE IT FURTHER RESOLVED that certified copies of this  
39 Resolution be transmitted to the Governor; Lieutenant Governor;  
40 Office of the Administrative Director of the Courts of the  
41 Hawaii State Judiciary; Comptroller; Director of Finance;  
42 Director of Business, Economic Development, and Tourism;
