Your Committee received testimony in support of the nomination of Michael Moore from the Department of Human Services.

Upon review of Michael Moore's resume, statement, and the testimony in support of his nomination for appointment and reappointment, your Committee finds that Michael Moore's professional experience, background, and commitment to public service, which he has developed as the Executive Director of Learning Disabilities Association of Hawaii, which is a training and information center for parents of youth with disabilities, and as a practicing counselor for more than two decades, qualify him for appointment and reappointment to the State Rehabilitation Council.
