Your Committee on Finance, to which was referred H.B. No. 1111, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO RECORDS OF THE HAWAII HEALTH SYSTEMS CORPORATION,"

begs leave to report as follows:

The purpose of this measure is to:

- Authorize the Hawaii Health Systems Corporation to set rates for copies of records that are protected from certain disclosure requirements; and
- (2) Establish minimum and maximum rates for copies of medical records.

The Hawaii Health Systems Corporation testified in support of this measure.

Your Committee has amended this measure by:

- Changing the minimum and maximum rates for copies of medical records to unspecified amounts; and
- (2) Making technical, nonsubstantive amendments for clarity, consistency, and style.
