Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 2034, H.D. 1, S.D. 2, entitled:

"A BILL FOR AN ACT MAKING AN APPROPRIATION TO THE KAHO OLAWE ISLAND RESERVE COMMISSION,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to support the Kahoʻolawe Island Reserve Commission's restoration and management of the Kahoʻolawe Island Reserve by requiring the Commission to submit a financial self-sufficiency and sustainability plan to the Legislature and appropriating funds for Commission activities including restoration and preservation of the Reserve's natural, cultural, and historic resources and its continued safe and meaningful use.

Your Committee on Conference has amended this measure by:

(1) Inserting an appropriation amount of \$450,000; and



(2) Changing its effective date to July 1, 2016.
