Your Committee on Conference on the disagreeing vote of the House of Representatives to the amendments proposed by the Senate in H.B. No. 2156, H.D. 2, S.D. 2, entitled:

"A BILL FOR AN ACT RELATING TO CAMPAIGN FINANCE,"

having met, and after full and free discussion, has agreed to recommend and does recommend to the respective Houses the final passage of this bill in an amended form.

The purpose of this measure is to reform the campaign finance laws relating to the use of campaign funds and the financing of the Campaign Spending Commission's operations. Specifically, the measure:

- Increases the options available to candidate committees and noncandidate committees in their use and disposition of campaign funds;
- (2) Repeals the use of the Hawaii election campaign fund for the operating expenses of the Campaign Spending Commission; and

(3) Appropriates general funds to the Campaign Spending Commission for operating expenses.

Your Committee on Conference has amended this measure by:

- Deleting the amendment that allowed a candidate, (1) treasurer, or candidate committee to make donations from campaign funds to private schools;
- (2) Deleting the provisions that allowed a deceased candidate's committee to use campaign funds to make donations to certain types of organizations, return the residual funds to the contributors, or both;
- (3) Deleting the amendment that would have repealed the use of Hawaii election campaign funds for Campaign Spending Commission operating expenses;
- (4) Deleting the appropriation for the Campaign Spending Commission's operating expenses; and
- (5) Making it take effect upon its approval.

As affirmed by the record of votes of the managers of your Committee on Conference that is attached to this report, your Committee on Conference is in accord with the intent and purpose of H.B. No. 2156, H.D. 2, S.D. 2, as amended herein, and recommends that it pass Final Réading in the form attached hereto as H.B. No. 2156, H.D. 2, S.D. 2, C.D. 1.
