The purpose of this measure is to assist sugar workers affected by the cessation of sugar production on Maui by:

- Appropriating funds to the Department of Labor and Industrial Relations (DLIR) for workforce development, worker training and retraining, and other assistance programs for these workers; and
- (2) Requiring DLIR to seek assistance from the United States Department of Labor to provide such support to these workers.

The Mayor of the County of Maui; a Councilmember of the County of Maui; Chamber of Commerce Hawaii; Alexander & Baldwin, Inc.; Hawaii Farm Bureau; and International Brotherhood of Electrical Workers Local Union 1260 testified in support of this measure.
