Specifically, this measure ensures that the Department's hiring process is consistent between its Law Enforcement and Corrections Divisions by explicitly excepting the Department from the unlawful employment practice provisions of Chapter 378, Hawaii Revised Statutes, when administering lie detector tests.

The Department of Labor and Industrial Relations and the Department of Public Safety supported this measure.


