The Department of Land and Natural Resources provided testimony in support of this measure. The Department of Budget and Finance and Department of the Attorney General provided comments.


Your Committee has amended this measure by:

(4) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.
