Your Committee on Public Safety, to which was referred H.C.R. No. 68 entitled:

"HOUSE CONCURRENT RESOLUTION ENCOURAGING THE DEPARTMENT OF PUBLIC SAFETY TO CONTINUE AND EXPAND ITS COMMUNITY-BASED WORK FURLOUGH PROGRAMS TO ASSIST FORMERLY INCARCERATED FEMALE INMATES TRANSITION BACK INTO SOCIETY,"

begs leave to report as follows:

The purpose of this measure is to encourage the Department of Public Safety to continue and expand its structured, community-based work furlough programs to help formerly incarcerated female offenders adjust to greater independence as they transition back into society.

The Department of Public Safety; Hawaii State Commission on the Status of Women; YWCA Oahu; YWCA Fernhurst; Ho'omana Pono, LLC; The CHOW Project; Hawai'i State Democratic Women's Caucus; Community Alliance on Prisons; and numerous concerned individuals supported this measure. One concerned individual offered comments.

As affirmed by the record of votes of the members of your Committee on Public Safety that is attached to this report, your Committee concurs with the intent and purpose of H.C.R. No. 68 and recommends that it be referred to your Committee on Finance.
