Your Committee on Health, to which was referred H.R. No. 114 entitled:

"HOUSE RESOLUTION REQUESTING THE PRESIDENT OF THE UNITED STATES, GOVERNOR OF HAWAII, HAWAII'S CONGRESSIONAL DELEGATION, CENTERS FOR DISEASE CONTROL AND PREVENTION, AND FEDERAL AVIATION ADMINISTRATION TO PROACTIVELY WORK TOWARD PREVENTION AND CONTROL OF THE ZIKA VIRUS,"
