Your Committee on Judiciary and Labor, to which was referred
S.B. No. 1076 entitled:

"A BILL FOR AN ACT MAKING APPROPRIATIONS FOR COLLECTIVE
BARGAINING COST ITEMS,"

begs leave to report as follows:

The purpose and intent of this measure is to appropriate and
authorize funds for the collective bargaining agreement for
employees in collective bargaining unit (14) and their excluded
counterparts.

Your Committee received testimony in support of this measure
from the Department of Budget and Finance, Office of Collective
Bargaining, and Hawaii Government Employees Association.

Your Committee finds that this measure provides a necessary
vehicle for the funding of the collective bargained terms reached
with regard to collective bargaining unit (14) and its excluded
counterparts. Your Committee believes that it is more appropriate
for your Committee on Ways and Means to determine the amounts of
funding to be included in this measure.

Your Committee has amended this measure by:


- (1) Inserting an effective date of January 7, 2059, to
encourage further discussion; and



- (2) Making technical, nonsubstantive amendments for the purposes of clarity and consistency.
