Your Committee on Ocean, Marine Resources, & Hawaiian
Affairs, to which was referred S.B. No. 1248, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO HAWAIIAN LANGUAGE,"

begs leave to report as follows:

The purpose of this measure is to enable the Hawaiian
Language College at the University of Hawaii at Hilo to realize
the benefits of revenues generated by the College and its various
programs by expanding the statutory scope of the Hawaiian Language
College Revolving Fund.

Your Committee received testimony in support of this measure
from the Office of Hawaiian Affairs, College of Hawaiian Language
at the University of Hawaii at Hilo, 'Aha Punana Leo, and several
individuals. The University of Hawai'i at Hilo and an individual
submitted comments.

Your Committee finds that this measure increases the Hawaiian
Language College's financial self-sufficiency by permitting the
College to realize the revenues generated by its own enterprises,
including fees for services and training and the sale of
publications. Your Committee notes that the impact of this
measure on the State's revenues is neutral-to-positive, as it
increases the College's capacity without expending general
revenues of the State.


