Your Committees on Health and Judiciary, to which was referred S.B. No. 2384, S.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO LICENSING INSPECTIONS,"

beg leave to report as follows:

The purpose of this measure is to require the Department of Health (DOH) to conduct:

- Unannounced visits and inspections, including inspections for relicensing or recertification, for certain state-licensed or state-certified care facilities on an annual basis at intervals determined by DOH; and
- (2) Unannounced inspections for license renewals for medical marijuana production centers and dispensaries.

The Policy Advisory Board for Elderly Affairs and two individuals testified in support of this measure. DOH supported this measure with amendments. The Adult Foster Homecare Association of Hawaii, Alliance of Residential Care Administrators, and numerous individuals testified in opposition to this measure. The State Council on Developmental Disabilities commented on this measure.

Your Committees have amended this measure by changing its effective date to July 1, 2112, to encourage further discussion.




