Your Committee has amended this measure to:

- Require the Judiciary to report annually on its administratively created funds and accounts by replacing an amendment to chapter 601, Hawaii Revised Statutes (HRS), with an amendment to section 37-52.5, HRS, that deletes the Judiciary's exemption from reporting; and
- (2) Make technical, nonsubstantive amendments for clarity, consistency, and style.
