Your Committee has amended this measure by:

- Changing the amount transferred from the Rental Assistance Revolving Fund to the Rental Housing Revolving Fund to an unspecified sum;
- (2) Changing the effective date to July 1, 2030, to encourage further discussion; and
- (3) Making technical, nonsubstantive amendments for the purposes of clarity, consistency, and style.


