Sir:

Your Committee on Judiciary and Labor, to which was referred  
S.B. No. 2836 entitled:

"A BILL FOR AN ACT MAKING APPROPRIATIONS FOR COLLECTIVE  
BARGAINING COST ITEMS,"

begs leave to report as follows:

The purpose and intent of this measure is to appropriate and  
authorize funds for the collective bargaining agreement for  
employees in collective bargaining unit (14) and their excluded  
counterparts.

Your Committee received testimony in support of this measure  
from the Department of Budget and Finance; Hawaii Government  
Employees Association, AFSCME Local 152, AFL-CIO; and one  
individual.

Your Committee finds that the negotiations for collective  
bargaining agreements for bargaining unit (14) are currently in  
progress. According to the Department of Budget and Finance, an  
arbitration award for collective bargaining unit (14) is expected  
before the end of February 2016. This measure provides a  
legislative vehicle that can be used if an agreement is reached or  
an arbitration award is issued.

Your Committee has amended this measure by making technical,  
nonsubstantive amendments for the purposes of clarity and  
consistency.


