Sir:

Your Committee on Judiciary and Labor, to which was referred
S.B. No. 2844 entitled:

"A BILL FOR AN ACT RELATING TO DISPOSITION OF EXCESS
REVENUES,"

begs leave to report as follows:

The purpose and intent of this measure is to reauthorize
\$10,000,000 in general revenues to be deposited into the emergency
and budget reserve fund.

Your Committee received testimony in support of this measure
from the Department of Budget and Finance.

Your Committee finds that the Legislature authorized the
appropriation of \$10,000,000 in general revenues to be deposited
into the emergency and budget reserve fund under Act 202, Session
Laws of Hawaii 2015. However, Act 202 was signed by the Governor
on July 2, 2015, two days after the end of fiscal year 2014-2015,
and the monies appropriated could not be deposited. This measure
corrects inadvertent errors in the approval processing.

Your Committee has amended this measure by making technical,
nonsubstantive amendments for the purposes of clarity and
consistency.

As affirmed by the record of votes of the members of your
Committee on Judiciary and Labor that is attached to this report,
your Committee is in accord with the intent and purpose of S.B.
