Sir:

Your Committees on Housing and Water, Land, and Agriculture,
to which was referred S.B. No. 2876 entitled:

"A BILL FOR AN ACT RELATING TO PUBLIC LANDS,"

beg leave to report as follows:

The purpose and intent of this measure is to exempt lands to
which the Hawaii Public Housing Authority holds title from the
definition of "public lands" in section 171-2, Hawaii Revised
Statutes.

Your Committees received testimony in support of this measure
from the Hawaii Public Housing Authority.

Your Committees find that the Hawaii Public Housing Authority
is authorized to acquire, own, and hold real property; therefore,
its titled lands do not fall under the catchall jurisdiction of
state "public lands" under the Department of Land and Natural
Resources' jurisdiction. The Hawaii Housing Finance and
Development Corporation lands have been exempted from the
definition of "public lands" under section 171-2, Hawaii Revised
Statutes. Accordingly, the Hawaii Public Housing Authority lands
should also be exempted from "public lands" as this exemption will
clarify the ability of the Authority to take certain actions on
its lands.


Your Committees have amended this measure by making a

and consistency.




