The purpose and intent of this measure is to approve the sale
of the leased fee interest in 94-946 Meheula Parkway, No. 264,
Mililani, Hawaii, in a manner that complies with section 171-64.7,
Hawaii Revised Statutes.

Your Committee received written comments in support of this
measure from the Department of Business, Economic Development, and
Tourism; Hawaii Housing Finance and Development Corporation; and
one individual.

Your Committee received written comments on this measure from
the Office of Hawaiian Affairs.

Your Committee recognizes that the Hawaii Housing Finance and
Development Corporation is attempting to sell the leased fee
interest in 94-946 Meheula Parkway, No. 264 to its current
leasehold owner. Your Committee finds that the Hawaii Housing
Finance and Development Corporation and the language of this
measure have complied with several necessary prerequisites for the
sale of the property, as set forth in section 171-64.7, Hawaii
Revised Statutes. Your Committee therefore finds that the



proposed sale meets the statutory requirements for approval of the sale.
