Sir:

Your Committee on Ways and Means, to which was referred
S.C.R. No. 14 entitled:

"SENATE CONCURRENT RESOLUTION AUTHORIZING THE ISSUANCE OF A
TERM, NON-EXCLUSIVE EASEMENT COVERING PORTION OF STATE
SUBMERGED LANDS AT KAIPAPAU, KOOLAULO, OAHU, FOR THE
MAINTENANCE AND REPAIR OF THE EXISTING ROCK SEAWALL, AND FOR
USE, REPAIR, AND MAINTENANCE OF THE EXISTING IMPROVEMENTS
CONSTRUCTED THEREON,"

begs leave to report as follows:

The purpose and intent of this measure is to authorize the
Board of Land and Natural Resources to issue a term, non-exclusive
easement covering a portion of state submerged lands fronting the
property identified as Tax Map Key: (1) 5-4-003: seaward of 035,
Kaipapau, Koolauloa, Oahu, for the maintenance and repair of the
existing rock seawall, and for the use, repair, and maintenance of
the existing improvements constructed thereon.

Your Committee received written comments in support of this
measure from the Department of Land and Natural Resources.

Your Committee finds that section 171-53, Hawaii Revised
Statutes, requires the prior approval of the Governor and prior
authorization of the Legislature by concurrent resolution for this
disposition of state submerged lands.

Your Committee also finds that portions of the existing rock
seawall fronting the property identified as Tax Map Key: (1) 5-4-
003: seaward of 035, Kaipapau, Koolauloa, Oahu, was placed upon

state submerged lands. Your Committee further finds that, on July 10, 2015, under agenda item D-7, the Board of Land and Natural Resources approved a grant of a fifty-five-year non-exclusive easement to resolve the encroachment.

As affirmed by the record of votes of the members of your Committee on Ways and Means that is attached to this report, your Committee concurs with the intent and purpose of S.C.R. No. 14 and recommends its adoption.


