Your Committees on Public Safety, Intergovernmental, and Military Affairs and Transportation and Energy, to which was referred S.C.R. No. 32 entitled:

"SENATE CONCURRENT RESOLUTION REQUESTING THE GOVERNOR TO RENAME A SECTION OF KAPULE HIGHWAY IN THE COUNTY OF KAUA'I AS THE KAUA'I VETERANS MEMORIAL HIGHWAY,"

The purpose and intent of this measure is to request the Governor to rename a section of Kapule Highway as the Kaua'i Veterans Memorial Highway.




