"SENATE RESOLUTION REQUESTING THE GOVERNOR TO RENAME A SECTION OF KAPULE HIGHWAY IN THE COUNTY OF KAUA'I AS THE KAUA'I VETERANS MEMORIAL HIGHWAY,"

beg leave to report as follows:

The purpose and intent of this measure is to request the Governor to rename a section of Kapule Highway as the Kaua'i Veterans Memorial Highway.
