HB 2510 EDN, FIN Status Authorizes the Hawaii Housing Finance and Development Corporation to establish a housing voucher program for full-time classroom teachers employed by the Department of Education, including classroom teachers at public charter schools. HB 2538 RELATING TO URBAN SCHOOL IMPACT DISTRICTS. EDN, WAL, FIN Status Allows fee in lieu funds in the Kalihi to Ala Moana school impact district to be used to purchase completed construction, construct new school facilities, improve or renovate existing structures for school use, or lease land or facilities for school use.
