EEP/EDN, FIN

Provides for air conditioning, heat abatement, and related energy efficiency measures at public schools by appropriating general funds and general obligation bond funds to the DOE for these projects. (SD2)

DECISION MAKING TO FOLLOW

Persons wishing to offer comments should submit testimony at least 24 hours prior to the hearing. Testimony should indicate:

- The date and time of the hearing; and
- Measure number.
