Status

RELATING TO CESSPOOLS.
Disallows the tax credit for cesspool upgrade, conversion, or connection for taxpayers whose federal adjusted gross income exceeds certain amounts. Effective 1/1/2050. (SD1)

DECISION MAKING TO FOLLOW


