Clarifies that under the Hawaii Post-Secondary Education Authorization Program, when an institution ceases to operate, the student transcripts will be kept permanently in a form prescribed by the director and other records requested and obtained by DCCA may be disposed of at the director's discretion. Requires UH to train employees and students on sexual harassment policies, appoint a campus advocate at each campus for students to discuss incidents of sexual harassment, report sexual assault cases to the police, and conduct a campus climate survey. Prohibits romantic relationships between, among others, a UH student and a UH faculty member. (HB2772 HD1)
