HLT/EEP, FIN

Requires the department of health to establish the Hawaii battery storage recycling task force to make recommendations for a workable recycling program for battery storage devices in Hawaii. Requires the task force to submit an interim report and final report to the legislature. (SD2)

DECISION MAKING TO FOLLOW

Persons wishing to offer comments should submit testimony at least 24 hours prior to the hearing. Testimony should indicate:

- The Committee(s) to which the comments are directed;
- The date and time of the hearing; and
- Measure number.
