<u>SB 2723</u> <u>Status & Testimony</u>	RELATING TO ENFORCEMENT OF WAGE LAWS. Changes the penalties for government contractors who violate wages and hours laws. Makes penalties \$1,000 for the first offense and ten per cent of the contract amount for the second offense.	JDL, WAM
