RELATING TO THE RELEASE OF CERTAIN
MISDEMEANANTS.

PBS, JUD

Defines the circumstance for the Director of Public Safety to release pretrial and sentenced misdemeanants at community correctional centers. (HB2391 HD1)

HB 2740, HD1
(HSCR207-16)
Status

RELATING TO LIABILITY.

HLT, JUD

Prohibits health insurance preauthorization requirements that cause undue delay in receipt of medical treatment or services. Specifies that insurers, but not health care providers, are liable for civil damages caused by undue delays for preauthorization. (HB2740 HD1)

DECISION MAKING TO FOLLOW



Persons wishing to offer comments should submit testimony at least 24 hours prior to the hearing. Testimony should indicate:

- Testifier's name with position/title and organization;
- The Committee(s) to which the comments are directed;
- The date and time of the hearing; and
- Measure number.

While every effort will be made to incorporate all testimony received, materials received on the day of the hearing or improperly identified or directed, may be distributed to the Committee after the hearing.

Submit testimony in ONE of the following ways:

PAPER: 19 copies (including an original) to Room 305 in the State Capitol;

FAX: For testimony less than 5 pages in length, transmit to 808-586-6531 (Oahu) or 1-800-535-3859 (for Neighbor Islander without a computer to submit testimony through e-mail or the Web); or

WEB: For testimony less than 10MB in size, transmit from <http://www.capitol.hawaii.gov/submittestimony.aspx>.

Testimony submitted will be placed on the legislative website. This public posting of testimony on the website should be considered when including personal information in your testimony. **Those wishing to provide oral testimony will be limited to two minutes.**
