In light of recent reports by the Associated Press that alleged unacceptable living and working conditions for foreign labor workers on commercial fishing vessels docked at Honolulu Harbor, the Committees have invited representatives from the commercial fishing industry, state departments and community groups to implement strategies and solutions to address the issue.
