RELATING TO THE POSSESSION OF FIREARMS WHILE
CONSUMING OR UNDER THE INFLUENCE OF AN
INTOXICANT.

PSM, JDL

Prohibits the actual physical possession of any firearm while
consuming alcohol outside of the home, a temporary residence, or
place of sojourn. Establishes violation as a petty misdemeanor.

RELATING TO CRIMINAL HISTORY RECORD CHECKS.

PSM, JDL

Authorizes county police departments to enroll firearms applicants
and individuals who are registering their firearms into a criminal
record monitoring service used to alert police when an owner of a
firearm is arrested for a criminal offense anywhere in the country.
