Authorizes a police officer to cause to be towed a motor vehicle if the operator is arrested or cited for certain intoxicant-related offenses. Provides exceptions. Provides notice and hearing requirements. (HB1747 HD1)	TRE/PSM, JDL

Requires the Director of Finance to issue moped number plates. Requires annual registration of mopeds. Stipulates registration fee for a moped shall be \$50. (HB1753 HD3)	TRE/PSM, WAM
<a href="#"><u>HB 2049, HD2</u></a> <a href="#"><u>(HSCR824-16)</u></a> <a href="#"><u>Status &amp; Testimony</u></a>	RELATING TO TRANSPORTATION. Authorizes the State or a county to obtain ownership over a road by condemnation pursuant to the State's powers of eminent domain. Exempts the State and counties from maintaining or improving condemned roads. (HB2049 HD2)	TRE/PSM, JDL/ WAM
<a href="#"><u>HB 2086, HD2</u></a> <a href="#"><u>(HSCR971-16)</u></a> <a href="#"><u>Status &amp; Testimony</u></a>	RELATING TO TRANSPORTATION. Amends the statewide transportation plan to include bicycle facilities as part of the transportation system components. Requires the Department of Transportation to develop a survey on travel behavior. Requires each county to develop transportation mode sharing plans and to update these plans every six years beginning in 2019. (HB2086 HD2)	TRE/PSM, WAM
