Status

RELATING TO TRANSPORTATION.
Establishes a speed limit of sixty miles per hour for the Daniel K. Inouye highway beginning at mile marker 19. Clarifies that the speed limit beginning at the Pohakuloa training area and ending one-half mile east of the Mauna Kea county park entrance, shall be forty-five miles per hour or any other speed limit determined by law. (SD1)

DECISION MAKING TO FOLLOW
