Provides the chairperson of the commission with the authority to establish an advisory committee composed of past commission members to advise the chairperson on historical and archival background of the commission. Amends the support staff function. Amends the mission and purpose of the commission.

Status

RELATING TO INCIDENT RESPONSE.

VMI, FIN

Requires the cybersecurity, economic, education, and infrastructure security coordinator to develop and maintain an incident response plan to cyber-attacks for each executive department in the State.

DECISION MAKING TO FOLLOW

Persons wishing to offer comments should submit testimony at least 24 hours prior to the hearing. Testimony should indicate:

- The date and time of the hearing; and
- Measure number.

PAPER: Twenty copies (including an original) to Room 322 in the State Capitol;


