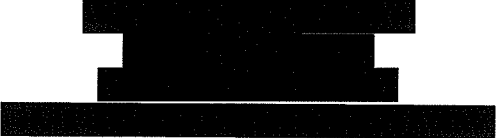

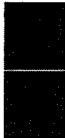

- Piloted a marine science program and managed the school audiovisual program.
- Head advisor for multicultural club focused on teamwork.

Vice-principal, Konawaena High and Highlands Intermediate schools.

- Managed the daily operations of the school focused on facilities and student discipline.
- Directed school operations during the strike and dealt with media representatives.

Principal, Laupahoehoe High and Elementary School.

- Collaborated with community and staff to (1) assess and improve school discipline and (2) successfully complete the accreditation process.
- Initiated major curricular review in all content areas with emphasis on writing.

- Collaborated with Public Safety to provide educational programs for the incarcerated.
- Initiated and provided the leadership for the development and implementation of a marketing plan for the school.
- Met with a variety of organizations to promote the school.
