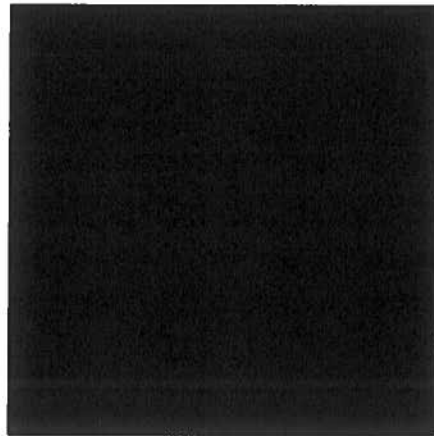

"Surfing with Soft Contact Lenses" CONTACT LENS FORUM, August 1985

Based on studies I did at the optometric clinic of Drs. Kuwabara & Yamane with Bausch & Lomb and Cooper Vision contact lenses, this article reported on the feasibility of wearing soft contact lenses while surfing or body surfing. One of the greatest concerns was the 'loss of lenses in the water' and the increased risk of eye infections with the use of contact lenses in the aquatic environment.

"Contact Lens Recommendations for Water Sports" CONTACT LENS SPECTRUM, June 1987

After numerous requests by contact lens manufacturers for studies on contact lens use in the oceans, lakes and pools, I was able to make contact lens fitting recommendations for different water sports. This article focused on the “Do’s” and “Don’ts” when fitting contact lens patients for water sports activities.

With the introduction of disposable contact lenses, I was again asked by major contact lens manufacturers to study the feasibility of the wearing of disposable contact lenses while enjoying water sports activities.
