#### John W. Roberts, M.B.A., CPA, CGMA Board of Public Accountancy

(1) Why do you want to be a member of the Board?

I want to be a member of the State of Hawaii Board of Public Accountancy in order to give back to my profession and to protect consumers' interests. Public accounting helps society allocate of resources efficiently. The value of the profession depends on the public's trust, and that trust is built on CPA licensing for the protection of consumers and the public as a whole.

(2) What do you perceive are the roles and responsibilities of a member of the Board?

I perceive the primary role of a member of the Board of Public Accountancy is to protect consumers through the implementation of the Hawaii Revised Statutes and Hawaii Administrative Rules; the development of revisions to these Statutes and Rules, when warranted, to further protect Hawaii's consumers as the practice of public accounting evolves due to changes in commerce and technology; and the maintenance of an adequate supply of competent public accounting service providers to meet the needs of Hawaii's consumers today and tomorrow.

I perceive the responsibilities of a Board member to safeguard the interests of Hawaii's consumers by being familiar with the laws and rules regulating the practice of public accountancy in Hawaii; familiar with current developments in the profession both inside and outside of the State of Hawaii; and in communication with a broad range of consumers and public accounting practitioners in the State of Hawaii.

(3) In what ways do you feel that you can help protect the consumer?

I feel that I can help protect consumers by working within the Board to ensure that high quality and competent services are available and provided to the public.

(4) Given your understanding of the roles and responsibilities of a Board member, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise and knowledge that would aid you as a member of the Board.

In addition to working as an accountant for two of the "Big Four" public accounting firms (Deloitte in Hawaii and KPMG in Alaska), I have worked as an employee and now owner of a local CPA firm on a neighbor island (Maui). I have worked in the audit of financial statements, tax compliance, and management consulting areas of the profession serving a broad range of clients and industries. Furthermore, I served on the State of Hawaii Tax Review Commission from 2005 to 2007 as well as served as president of the Hawaii Association of Public Accountants (HAPA) from 2009 to 2014.

This combination of experience has given me a broad understanding of the issues facing the public accounting profession in Hawaii.

5) What do you hope to accomplish during your term of service?

I hope to help improve the transparency and accountability of the Board of Public Accountancy and increase its effectiveness as a protector of the public.

(6) Name three qualities that best describe you and how these qualities will benefit the Board.

In my opinion, the three qualities that best describe me are: 1) careful and deliberate before passing judgment, 2) responsive and open to the public, and 3) competent in a broad range of public accounting issues. The work of the Board of Public Accountancy requires a balance of all three qualities so that consumers perceive that their expectations have been met while the licensing and regulatory framework of the CPA profession in Hawaii is administered fairly and equitably.

(7) Name a previous experience you've had that will be beneficial as a Board member.

I served on the State of Hawaii Tax Review Commission from 2005 to 2007 and was a qualified peer reviewer.

(8) Can you foresee any possible conflicts of interest that could arise during your service on the Board? How would you overcome conflicts of interest?

Until my recent interim appointment to the Board of Public Accountancy, I served as the immediate past president of HAPA and a member of HAPA's legislative committee. Upon receiving an interim appointment, HAPA's board of directors granted my request to resign from all substantive responsibilities with HAPA and suspend my voting rights as immediate past president at all HAPA board of director meetings. If a future conflict of interest arises, I will disclose the conflict and ask for a ruling from the chairperson of the Board of Public Accountancy.
