- 9 comprising 58% of the islands total population. Bay Clinic is also the sole safety-net provider
- 10 of primary, dental, and behavioral health care for East and South Hawaii Island.
- 11 Mr. Wallace was formerly the Interim Chief Executive Officer for Total Healthcare
- 12 Center of Tyler, Texas, Vice President of Ambulatory Services for Schneider Regional Medical
- 13 Center of St. Thomas-St. John, U.S. Virgin Islands, and Chief Operating Officer for Samuel U.
- 14 Rodgers Health Center of Kansas City, Missouri.
