The State Council on Developmental Disabilities (DD) **STRONGLY SUPPORTS GM 571** to confirm the nomination of Robin Coverlissa for a term to expire June 30, 2016.

The Council's Federal mandate (P.L.106-402) is clear in determining the composition of this body to ensure that all the stakeholders are represented and engaged in the development and implementation of a comprehensive system of services and supports for individuals with DD.

The law specifically requires that not less than 60 percent of the membership of the Council be comprised of individuals with DD, parents, immediate relatives or guardians. Additionally, each Council shall include representatives of relevant State entities, including State entities that administer funds provided under Federal laws related to individuals with disabilities, including the Rehabilitation Act of 1973 (29 U.S.C. 701 et seq.), Individuals with Disabilities Education Act (20 U.S.C. 1400 et seq.), Older Americans Act of 1965 (42 U.S.C. 3001 et seq.), and Titles V and XIX of the Social Security Act (42 U.S.C. 701 et seq. and 1396 et seq.); Centers for Excellence in DD Education, Research, and Service; State Protection and Advocacy system; and representatives, at all times, of local and non-governmental agencies, and private nonprofit groups concerned with services for individuals with DD in the State.

The Governor's nominee meets all the Federal requirements for Council membership. Ms. Coverlissa's appointment to the Council would fulfill the Federal requirement for representatives of individuals with DD. Ms. Coverlissa receives services through the Medicaid Home and Community-Based Services Waiver from Easter Seals Hawaii-Ewa. She has attended several of the Council's annual Day at the Capitol events, and has well represented others with a strong voice.

Ms. Coverlissa is an active member of the Hawaii Self-Advocacy Advisory Council (SAAC) and participates in monthly meetings, leadership training, and advocacy outreach activities. The Council looks forward to her contributions in assisting with the implementation of activities to strengthen SAAC and establishing a statewide self-advocacy network.

We appreciate the opportunity to express our **strong support for GM 571 to confirm the appointment of Robin Coverlissa to the State Council on Developmental Disabilities.**

I believe I am qualified to serve on the DD Council because I have a developmental disability and I would represent other people with DD. I have a positive attitude in working with people.

As a person with DD who uses a wheelchair, I experience the day to day need to have someone assist me with transfer from the chair to the car and the bathroom. My experience as a person with DD would contribute to the DD Council's advocacy for services for people with DD.
- (8) Can you foresee any possible conflicts of interest that could arise during your service on the Board? How would you overcome conflicts of interest?
I receive services from Easter Seals Hawaii. There may be a conflict if Easter Seals Hawaii was going to receive any funds from the DD Council. In that case, if the DD Council was voting to give Easter Seals money, I would let the DD Council know that I receive services from Easter Seals Hawaii and I would excuse myself from voting.
