I am writing in response to your email dated February 17, 2016 requesting information. The following provides my responses to the questions:

(1) Why do you want to be a member of the Board?

I have served on the Statewide Health Coordinating Council since 2012 and have enjoyed the opportunities to help ensure access to healthcare on a broader level, along with providing networking opportunities.

(2) What do you perceive are the role and responsibilities of a member of the Board?

I understand that the State Health Planning and Development Agency (SHPDA) administers the Certificate of Need (CON) process and the periodic update of the State Health Plan. As I member of the Statewide Health Coordinating Council, I believe that my role would be to assist in reviewing CON applications providing comments, asking questions and making recommendations to SHPDA. In addition, I would assist in preparing and revising the Health Services and Facilities Plan.

(3) In what ways do you feel that you can protect the consumer?

By being an active participant and making independent judgments about the areas for decisions. I will strive to ensure that the consumer is protected in making decisions or deliberations.

(4) Given your understanding of the role and responsibilities of a Board member, why do you believe that you are qualified for the position? Please include a brief statement of your skills, expertise, or knowledge that would aid you as a member of the Board.

I have a Bachelor in Business Administration – major in accounting and a Master of Accounting (concentration in taxation) from the University of Hawaii at Manoa. After graduation I joined KPMG, LLP, auditing companies primarily in the healthcare, electric utility, construction and retail industries. During the last fifteen years I have worked in the healthcare provider industry at the Queen's Health Systems and Hawaii Pacific Health. During this time my responsibilities included financial reporting, accounting, accounts payable, payroll, government reimbursement and taxes. During my career, I have developed technical accounting, auditing, finance, general

business and analytical skills. In addition, my experience during the last fifteen years at large healthcare systems provides a unique perspective into healthcare needs from the provider's perspective. I believe that this experience may be beneficial in a role as a member of the Statewide Health Coordinating Council.

(5) What do you hope to accomplish during your term of service?

While performing reviews of CON applications, I hope to provide meaningful comments, questions and recommendations that will assist SHPDA in carrying out its responsibilities. I also hope to gain a better understanding of SHPDA and the Health Services and Facilities Plan.

(6) Name three qualities that best describe you and how these qualities will benefit the Board?

Reliability – I can be counted on to get assignments done on time and correctly. In relation to the Statewide Health Coordinating Council, I will be committed to performing my duties with the upmost care.

Analytical Abilities – During my work experiences I have developed strong analytical abilities. This quality should assist in evaluating complex proposals and issues.

Healthcare provider experience – With approximately fifteen years of healthcare provider experience, I should be able to evaluate issues from the unique provider perspective.

(7) Name one previous experience you've had that will be beneficial as a Board member.

One important project was the implementation of an accelerated financial statement closing timeline that enabled us to complete our financial audit in early October, as opposed to the previous late November timing. The project involved coordination of various personnel and resulted in a much more efficient audit process. This is one simple example that illustrates my strong analytical abilities that may be of benefit to the Statewide Health Planning Council.

(8) Can you foresee any possible conflicts of interest that could arise during your service on the Board? How would you overcome any possible conflicts of interest?

My assumption is that CON applications from the Queen's Health Systems would result in an instance of a conflict of interest - particularly if making recommendations to SHPDA. In addition, there will be instances in which a CON application involves a project/service in direct competition with the Queen's Health Systems. In these instances, I would notify the Council of the conflict and excuse myself from discussion or recommendations related to this matter.
