On behalf of Historic Hawai'i Foundation, I am writing in support for the confirmation of Wei Fang as a member of the Hawai'i Community Development Authority.

The Hawai'i Community Development Authority has jurisdiction over the land use and development of the Kaka'ako, Kalaeloa and He'eia districts on O'ahu. The HCDA board members have responsibility for ensuring the orderly and appropriate growth, redevelopment and community benefit of these districts, in accordance with the statutes, master plans, laws and regulations, and professional judgment.

HCDA's responsibilities cover three land areas, each with a very different character, history and needs. He'eia is primarily a preservation and conservation area of rural character, while Kalaeloa is a former naval base with a history connected to native Hawaiian, plantation, military, railroad and commercial uses and a suburban development pattern. Kaka'ako is in the center of the urban core, with more intense density and scale, with traditional development patterns, many historic buildings and transitional issues to the adjacent civic center, central business district, waterfront and tourism areas.

Wei Fang has a demonstrated record of listening and being responsive to community concerns about the nature and character of community development. She understands how various components of land use, urban design, financial constraints, legal obligations and community input can and should be considered, balanced and acted upon. Her comportment is respectful of others and she treats them with civility and professionalism.

Ms. Fang has first-hand experience as a small business owner and operator of a non-profit organization in Kaka'ako. She rehabilitated a historic warehouse in an adaptive reuse project, and made an underutilized space available for new activities. The community gathering place is innovative and vibrant, showcasing how old buildings can be put to new uses to support a vibrant redevelopment area.

HCDA will benefit greatly from Ms. Wang's experience, knowledge and demeanor. Therefore, we support her confirmation to the Hawai'i Community Development Authority.

Since 1974, Historic Hawai'i Foundation has been a statewide leader for historic preservation. 
