Answer: I worked, mostly as a volunteer, directly with the Park from the late 1970s through to the early 1990s. I was the first park coordinator. My book on Kahana came from many years of academic research that included reading most of the available extensive reports and manuscripts on the ahupua'a of Kahana.
