The Department of Land and Natural Resources (Department) supports Governor's Message 625, nominating Mr. Charles Mitchell to the Island Burial Council, Island of Oahu expiring June 30, 2019.

The Island Burial Councils are established under Section 6E-43.5, Hawaii Revised Statutes. With regard to previously known burials, the Burial Councils determine whether to leave the burial in place or remove it, recognize lineal and cultural descendants and provide counsel and advice to the Department.

Mr. Mitchell (Aulii) is a Cultural Anthropologist. He currently is employed by Cultural Surveys Hawaii as a Project Director and Cultural Advisor. He holds a B.A. in Anthropology with emphasis on Archaeology from the University of Hawaii-Hilo. He also has a Masters in Applied Indigenous Knowledge from Te Wanaga O Aotearoa Universities, Hamilton, New Zealand. As an employee of Cultural Surveys Hawaii, he has a wide expanse of knowledge and experience regarding the statutes and administrative rules guiding the SHPD's burials program. Aulii's professional affiliations include: Society for Hawaiian Archaeology, Ke Kula Na Mea Hawaii-School of Hawaiian Culture, and Kua O Ka La Public Charter School.

Senate confirmation will ensure that Mr. Mitchell's knowledge, experiences and perspective informs the deliberations of the Island Burial Council until June 30, 2019.

The Office of Hawaiian Affairs (OHA) <u>SUPPORTS</u> GM625, which confirms Charles "'Auli'i" Mitchell as the Wai'anae regional representative on the O'ahu Island Burial Council.

Mr. Mitchell has long demonstrated a deep interest in Native Hawaiian cultural practices and a passion for the preservation and protection of iwi kūpuna. His experience with archaeological resources and community consultation will make him an invaluable addition to the Oʻahu Island Burial Council.

A current resident of Wai'anae, Mr. Mitchell's dedication to the preservation of iwi kūpuna was inspired at a young age when, as a child, he was selected by his 'ohana to care for the iwi of his own kūpuna. He later supplemented his traditional training with a B.A. in Anthropology with an emphasis in archaeology from the University of Hawai'i at Hilo, and a Masters in Applied Indigenous Knowledge at Te Wānanga O Aotearoa University. Subsequently, Mr. Mitchell personally assisted with the repatriation of iwi kupuna and moepū, worked on the long term preservation plan for portions of a trail located in West Hawai'i Veteran's Cemetery, conducted the archaeological inventory survey for a 71 acre parcel in Kawela, and drafted several burial treatment plans. He has also conducted cultural assessments, and developed collections of traditions, historical accounts, and mo'olelo of Kea'au, Kahuwai, Pu'ala'a, Kauaea, and Kaueleau, and Hawai'i. Mr. Mitchell remains an active member of the Society for Hawaiian Archaeology. OHA believes that this lifetime of cultural and archaeological experience, combined with his experience working with communities from various locales, will allow Mr. Mitchell to contribute significantly to the O'ahu Island Burial Council and its work.

In addition to his archaeological and burial expertise, Mr. Mitchell has also demonstrated a deep interest in the broader perpetuation of his cultural heritage, which further counsels his appointment to the Council. Fluent in Hawaiian, Mr. Mitchell has worked as an interpreter and cultural specialist at the Lyman Mission House Memorial Museum in Hilo, and has dedicated much of his time to a variety of Hawaiian community and educational organizations. He currently serves on the board of directors of Ke Kula Nā Mea Hawai'i, as the president of Ho'oulu Lahui/Kua O Ka Lā Public Charter School, and as a kumu hula for Hālau O Kahiwahiwa & Hālau o Moana-nui-a-Kiwa. This extensive record of community service and

cultural perpetuation activities further reflects Mr. Mitchell's likely level of commitment to the Council and its important kuleana, should his nomination be confirmed.

For these reasons, OHA urges the Committee to <u>PASS</u> GM625, to confirm Mr. Mitchell to the O'ahu Island Burial Council. Mahalo for the opportunity to testify on this important measure.
