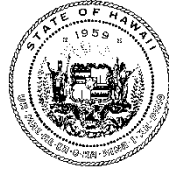

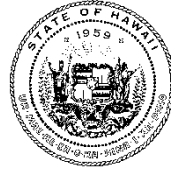
RELATING TO CONFIRMATION TO THE ENHANCED 911 BOARD, JEFFREY RIEWER

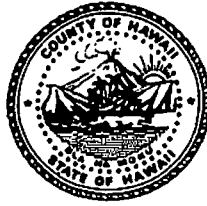


