TO THE HONORABLE ROSALYN H. BAKER, CHAIR,
AND MEMBERS OF THE COMMITTEE:

My name is Catherine Awakuni Colón, Director of the Department of Commerce and Consumer Affairs ("Department"). The Department appreciates the opportunity to provide testimony in support of Governor's Message Nos. 753 and 754, nominating Mr. Steven Chow for membership on the Motor Vehicle Industry Licensing Board ("Board") for terms to expire June 30, 2016, and June 30, 2020, respectively.

Mr. Chow has practiced law for nearly 35 years. He started with the law firm of Fujiyama, Duffy & Fujiyama in 1981, specializing in commercial and civil litigation. In 1994 he went on to found the firm known today as The Pacific Law Group.

Mr. Chow's past activities demonstrate his desire to serve the community. He served on various boards, including as past president for both Prevent Child Abuse Hawaii and Friends of Hickam, Inc. I had previously served two terms on the Board Of Chiropractic Examiners and two terms with the Motor Vehicle Repair Board. I want to continue on any Board that needs help. I understand there is a need for public members on the Motor Vehicle Industry Licensing Board (MVILB) and I know I can help.
