I am interested in being on the Statewide Health Coordinating Council based on my past 30 years experience in leadership roles in Healthcare both on the mainland and 20 years in Hawaii. Although I have retired I keep up with healthcare laws, Joint Commission and Medicare regulations, etc. and healthcare developments in the State of Hawaii.
